Summary And Strategy

The initial evaluation date is the 20th of February 2018 with a strike of 1000 EUR.

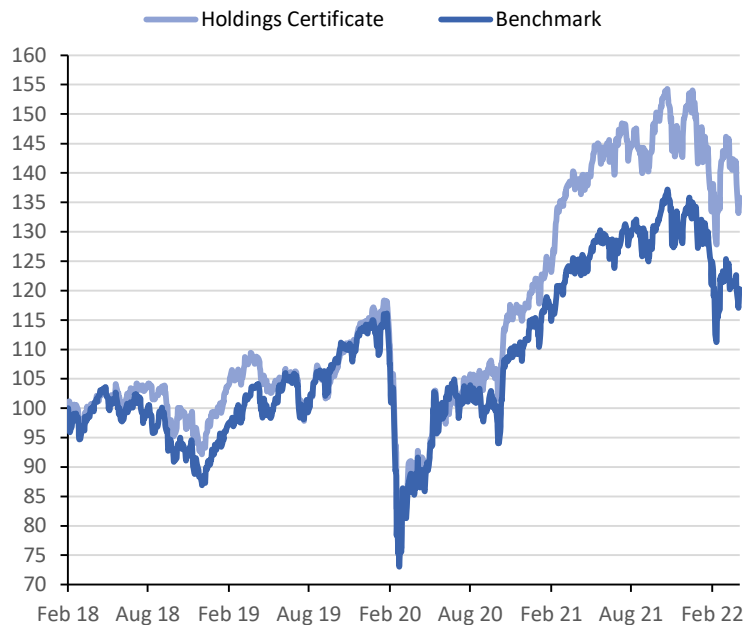

Evolution of NAV vs. Benchmark

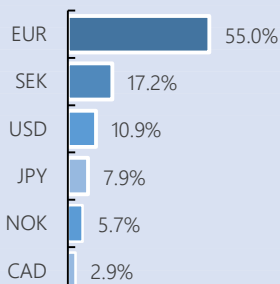

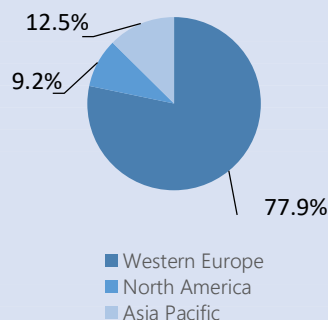

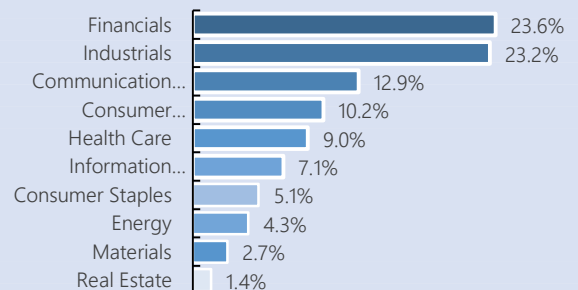
Currency Exposure
